ANNUAL DEVELOPMENT PLAN 2017/2018

Hon. Stephen Kiarie: I wish to lay before the House the Annual Development Plan for the year 2017/2018 that has been prepared with the following Articles of Public Finance Management Act 2012. Every County government shall prepare a development plan in accordance with Article 220 (2) of the constitution that include the following:-

1. Strategic Priorities for the medium term that reflects the County government priorities and plans
2. a description of how the county government is responding to changes in financial and economic environment
3. Programs to be delivered with details for each programs of the strategic priorities to which the programs will contribute.
4. The services or goods to be provided
5. Measurable indicators of performance where visible and the budget allocated to the programs
6. Payments to be made on behalf of the county government including details of any grants, benefits and subsidies that are to be paid
7. A description of significance capital development
8. A detail description of proposals with respect to the development of physical,interlectual ,human and other resources of the county including measurable indicators where those are visible

9. Such other matters as may be required by the constitution of this Act.
10. The County Executive Committee Member responsible for planning shall prepare the development plan in accordance with the format by the regulations thereof.
11. The County Executive Committee Member responsible for planning shall not later than 1ST September in each year submit the development plan to the County Assembly for approval and sent a copy to the Commission on Revenue Allocation and the national treasury.
12. The County Executive Member responsible for planning shall publish and publicize the Annual Development Plan within seven days after its submission to the County Assembly.
