## CONTRACTUAL VACANCIES

The County Assembly Service board is a body corporate established by Section 12 of the County Government Act. The Board is inter-alia, mandated by law to constitute offices in the Assembly service. Consequently, the Board invites applications from suitably qualified Kenyans to fill the following vacant position on contractual basis.

## ARTISAN I (MOTOR VEHICLE MECHANIC (1 POSITION - CONTRACTUAL) CONSOLIDATED SALARY Kshs 30,000 PER MONTH.

#### (a) Duties and responsibilities will entail:-

- (i) Inspecting and testing vehicles; completing preventive maintenance such as, engine tune-ups, oil changes, tire rotation and changes, wheel balancing, and replacing filters;
- (ii) Maintaining vehicle functional condition by listening to operator complaints; conducting inspections; repairing engine failures; repairing mechanical malfunctions, replacing parts and components;
- (iii) Verifying vehicle serviceability by conducting test drives; adjusting controlsand systems.
- (iv) preparing routine maintenance reports for motor vehicles;
- (v) filling appropriate documentation on each repair;
- (vi) Maintaining vehicle records by recording service and repairs.

- (ii) Kenya Certificate of Secondary Education mean grade D-(minus);
- (iii) Valid driver's license;
- (iv) Proven three years' experience in automotive repair in a busy garage and/or institution
